Vendor space assignment will take place the morning of Saturday, August 18, 2018. Must bring tables, chairs, equipment and lighting. Must stay within boundaries of 10 x 10 space NO EXCEPTIONS. Please have tablecloth long enough to cover front and side tables so no storage is exposed. Vendor is responsible for maintaining their tables, tents and surrounding area free of garbage. Garbage is to be stored in heavy duty trash bags and removed at the end of each evening. NO GREASE OR OIL ARE TO BE DISPOSED OF AT FESTIVAL SITE. Vendors must provide their own receptacles for oil/grease removal. JCFD will be onsite to issue immediate fines for any improper disposal of oil/grease. ALL FOOD VENDORS MUST BE WITHIN NJ COMMERCIAL HEALTH CODE GUIDELINES AND MUST HAVE A FUNCTIONING FIRE EXTINGUISHER ONSITE.
